



Anthony Wayne Crew Club Spring 2019 Dues

Dear Parents/Guardians,

Below is the invoice for the Anthony Wayne Crew Club, (AWCC) Spring 2019 season. As you review the invoice, please select a payment option. We have worked with the Foundation to hold dues to the same level as Fall 2018. We can accept check, cash or credit cards. The \$85.00 Toledo Rowing Club (TRC) Spring Membership is included in your dues amount. There is no need to pay this separately.

It is imperative to adhere to the payment due dates. Failure to do so can result in suspension of your athlete. We have put together the following payment options:

- If paying all at once, the amount is \$595.00. We would ask that you give your rower/coxswain your check or cash and give to Coach Meggie no later than 4/2/2019, or send to AWCC via our PO Box;
- Three installments by cash/check for the sum of \$615.00
- Five installments by Visa or Mastercard credit card for the sum of \$640.00
